

Terms and Conditions of Participation for “Bosch Home & Garden promotion – GOT BAG” for Great Britain

By entering the “Bosch Home & Garden promotion – GOT BAG” promotion (“**Promotion**”), participants agree to these Terms and Conditions of Participation.

1. Organiser

The organiser of this Promotion is

(hereinafter referred to as “**Bosch**”).

The agency PORTICA GmbH Marketing Support, Von-Galen-Straße 35, 47906 Kempen, Germany (hereinafter referred to as “**Agency**”) contracted by Bosch is assisting Bosch in the organisation/administration of the Promotion.

2. Promotion procedure

The Promotion period will commence on 15th September 2021 00.01 AM (CET) and end on 31st October 2021 11:59 PM (CET) (hereinafter referred to as “**Promotion Period**”). Eligible participants must register for the Promotion on the Competition Website (as defined below in section 4) no later than 15th November 2021 11:59 PM (CET) as detailed further below in section 4.

3. Eligible participants

To be eligible to participate, persons must reside in Great Britain and have reached the age of 18 at the time of participation. Employees of the Agency and their relatives as well as employees of the Bosch Group of companies and their relatives are excluded from participating. Participation using falsified identities or third-party identities is not permitted. Automated participation (e.g. via participation or registration services) as well as multiple entries are not permitted.

4. Participation

In order to take part in the Promotion, eligible participant must follow these steps:

- 1) Purchase a product from the Green Bosch DIY Home & Garden Power Tool range hereinafter referred to as (“**Bosch Home and Garden Product**”) excluding Accessories and Measuring Tools online or in store during the Promotion Period.
- 2) Visit the website at the following link: <https://gotbag.portica.com> (hereinafter referred to as “**Promotion Website**”).
- 3) Register for the Promotion by 11:59 (CET) 15th November 2021 (“Registration Closing Date”) by completing the mandatory fields marked with * and upload the invoice/receipt of your Bosch Home and Garden Product on the Promotion Website by taking a photograph of the invoice/receipt or uploading a file. Please note that the Bosch Home and Garden Product purchased must be clearly visible on the invoice/receipt.

5. Winnings, prize notification and prize delivery

All eligible participants who have participated in the Promotion as detailed in section 3 above will be entered into a prize draw to win one of 100 GOT BAG Rolltops worth £135 each. There will be 100 winners in total determined at random within two weeks of the Registration Closing Date. The winners will be sent the GOT BAG backpack within four weeks after the Registration Closing Date. There will be no separate prize notification but winner's name and county can be obtained by emailing to PT.DSO@bosch.com or sending a letter to Robert Bosch Power Tools GmbH, Max-Lang-Straße 40–46, 70771 Leinfelden-Echterdingen, Germany (enclosing a self-addressed envelope) within one month after the winner is selected as stated in this section 5. If you object to any or all of your surname, county and winning entry being published or made available, please contact Bosch at PT.DSO@bosch.com. In such circumstances, Bosch must still provide the information and winning entry to the Advertising Standards Authority on request.

If the winner cannot be contacted via the address provided, the notification is returned as undeliverable or if a winner fails to respond and accept their prize within the specified time period, the winner concerned will forfeit the prize. Bosch reserves the right in these cases to allocate the prize to another winner. The prize will be sent to the winner free of charge. The prize cannot be exchanged for another item or for a cash payment and it cannot be collected by the winner.

6. End of the Promotion

Bosch expressly reserves the right to end the Promotion without prior notice or providing a reason. This applies in particular to any reasons that would prevent or interfere with the planned Promotion procedure. However, Bosch will use its reasonable endeavours to minimise the effect of such amendment or termination to avoid disappointment. Any termination or amendment to the Promotion will be communicated in the same way as the Promotion was communicated.

7. Exclusions

(1) A breach of these Terms and Conditions of Participation entitles Bosch to exclude the respective participant from the Promotion. This shall be the case, in particular, if participants provide false information.

(2) If the excluded participant is a winner of the prize draw, the prize can be subsequently withdrawn.

8. Governing Law and jurisdiction

The Promotion shall be subject to the substantive laws of Germany, excluding the UN Convention on Contracts for the International Sale of Goods (CISG). Any dispute, controversy or claim arising out of or in relation to this agreement, including the validity, invalidity, breach or termination thereof, which cannot be settled amicably, shall be submitted to the jurisdiction of the competent courts of Stuttgart, Germany. As a consumer, the participant will benefit from any mandatory provisions of the law of the country in which you are resident. Nothing in these terms and conditions, including this section 8, affects your rights as a consumer to rely on such mandatory provisions of local law.

9. Data protection

Where personal data of participants is recorded, processed and used during the Promotion, this is only recorded, processed and used by Bosch for organising the competition and will be deleted after the end of the Promotion. All data will be deleted 30 days after the end of the

Promotion at the latest. Address information is only recorded for the winner and used to deliver the prize. This data will be stored in line with legal stipulations. Data shall not be passed on to third parties unless this is necessary for organising the Promotion and to deliver the prizes. Participants are entitled to their legal rights to information, rectification and withdrawal.

By participating in the Promotion, the participant agrees to Bosch storing and using their data for the purposes outlined above. The participant may object to the use of their data at any time. In this case, the data will be deleted immediately.
